SURVEYOR'S CERTIFICATE

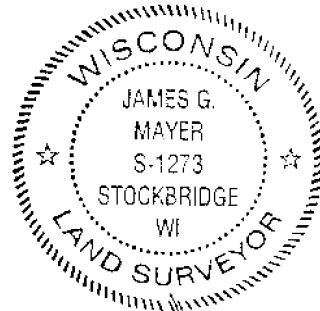
I, James G. Mayer, Wisconsin Registered Land Surveyor, hereby certify that I have surveyed, divided, and mapped under the direction of Arthur R. Schuelke, part of the Southeast Quarter and the Southwest Quarter of the Southeast Quarter of Section 26, Township 21 North, Range 14 East, Town of Caledonia, Waupaca County, Wisconsin containing 160,016 square feet or 3.67 acres of land and described as follows.

Commencing at the Southeast Corner of said Section 26; thence North 00°05'48" East a distance of 657.15 feet along the east line of the southeast quarter to the south line of the north-half of the south-half of the southeast quarter; thence South 89°52'03" West a distance of 1,001.01 feet along the south line to the west right-of-way line of County Trunk Highway "W" and the point of beginning; thence South 89°52'03" West a distance of 523.92 feet along the south to the west line of Volume 126 Deeds Page 94; thence North 26°54'20" West a distance of 315.06 feet along the west line to the south line of Certified Survey Map No. 4862; thence the following calls along Certified Survey Map No. 4862, North 69°14'29" East a distance 48.85 feet; thence North 20°45'31" West a distance of 139.05 feet; thence North 46°05'29" East a distance of 114.96 feet to the west right-of-way line of County Trunk Highway "W"; thence the following calls along the west right-of-way line South 46°17'46" East a distance of 43.65 feet; thence South 49°09'32" East a distance of 119.26 feet; thence South 48°29'16" East a distance of 480.21 feet; thence South 54°11'03" East a distance of 100.74 feet; thence South 48°29'16" East a distance of 32.34 feet to the point of beginning. Subject to all easements and restrictions of record. Liability hereunder is expressly limited to the cost of this survey.

That such map is a correct representation of all exterior boundaries of the land surveyed and the land division made thereof. That I have complied with the provisions of Chapter 236.34 of the Wisconsin Statutes and the Subdivision Regulations of Waupaca County and the Town of Caledonia in surveying, dividing and mapping such lands.
